She was a featured speaker at the 2016 Republican National Convention and the RNC named her a "Rising Star." Contributions to Kimberly Yee for Arizona Treasurer are not deductible as charitable contributions for federal income tax purposes. An individual may not contribute more than \$5,100 for the election cycle. A partnership may not contribute more than \$5,100 for the election cycle. Mega-PACs may not contribute more than \$5,100 for the election cycle. Mega-PACs may not contribute more than \$10,200 for the election cycle. Contributions from corporations, LLCs, labor unions, and foreign nationals (non-green card holders) are prohibited. Arizona law requires Kimberly Yee for Arizona Treasurer's best efforts to obtain, maintain, and report the name, address, occupation, and employer of any individual who contributes more than \$50 in an election cycle.
